The Issuer is a licensed cannabis producer pursuant to Health Canada's *Cannabis Act* and the Issuer specializes in cannabis cultivation. The Issuer built and operates a state-of-the-art production facility in B.C.'s North Okanagan region and currently sells premium dried cannabis flower on a wholesale basis to licensed producers in Canada.

On February 1, 2021, the Issuer reported financial results for the First Quarter of the 2021 Fiscal Year. The Issuer reported a fourth consecutive quarter with sales exceeding \$1 million with strong performance for the Kalifornia strain.

On February 6, 2021, the Issuer announced its Annual General Meeting ("AGM") results and welcomed Albert Duwyn to its Board of Directors.

On February 22, 2021, the Issuer announced a scheduled presentation at the Benzinga Cannabis Capital Conference and the presentation commenced on Friday February 26, 2021 at 12:30 EST. The Issuers management is focused on the production and sale of cannabis during the month. The Issuer as announced, plans to add up to an additional 30,000 square foot extension to its initial facility near Armstrong, B.C. Building permits have been approved by local officials and the Issuer is using this time to secure financing for the expansion of up to an additional 5,000 kg of premium cannabis per year.
