The Issuer entered into an option agreement with Exgen Resources Inc. dated December 6, 2019, pursuant to which the Company acquired an option to purchase up to a 80% interest in the Gordon Lake gold property located in the Northwest Territories. The Issuer continued exploration on the Pellaire property and filed the first National Instrument 43-101 Technical Report on the Pellaire

property. Assays of samples from the Golden Wonder property, located in Hazelton, British Columbia, are ongoing. The Issuer entered into a letter of intent with Mag One Products Inc. and its wholly-owned subsidiary Mag One Operations Inc. in November 2019, which remained in effect.

The Issuer entered into an option agreement with Exgen Resources Inc. dated December 6, 2019, pursuant to which the Issuer acquired an option to purchase up to a 80% interest in the Gordon Lake property. Pursuant to the option agreement, the Issuer may exercise the option by incurring the following: (a) \$250,000 in exploration expenditures during the first year of the option, (b) paying \$150,000 in cash and issuing 100,000 shares of the Issuer over a period of two years; (c) paying a further \$50,000 per year until the commencement of commercial production; and (d) issuing a further 650,000 shares of the Issuer upon achieving certain milestones as follows: (i) 100,000 shares upon obtaining a technical reporting establishing an updated resource estimate; (ii) 200,000 shares upon obtaining a further technical report establishing economics on the Property; and (iii) 350,000 shares upon commencing commercial production.
