**GABY Inc. is a California-focused retailer with its own proprietary brands in the market. GABY has relationships with over 500 retailers in the mainstream sales channel, and over 200 in the licensed channel, bridging the gap between the licensed dispensary and mainstream markets. A pioneer in the industry with a multi-vertical retail foundation, GABY owns a significant majority of its supply channels, including manufacturing, distribution, and retail. GABY is an employee-owned company, with 100% of full-time employees owning shares in the Company.**

**On February 4, 2021, GABY announced the closing of the Brokered Private Placement together with a non-brokered private placement of units of the Corporation for aggregate gross proceeds of C\$12.5 million. Proceeds from the Brokered Private Placement and the Non-Brokered Private Placement will be used to fund the closing of the Mankind Acquisition, as well as the pro forma business plan of the Corporation and for general corporate purposes. **On February 16, 2021, GABY announced that it had executed a definitive transaction agreement effective February 15<sup>th</sup>, 2021, in respect of its merger with Miramar Professional Services, which operates the Mankind Dispensary.**

**The Merger constitutes a "fundamental change" of the Company under the rules and policies of the Canadian Stock Exchange and, accordingly, trading in the Company's common shares has been halted and will remain halted until the completion of the Merger. Additional details regarding the Merger are available in the Company's press release dated December 3, 2020.**
