#### **Report on Business**

**During the month of May 2026, the Issuer advanced exploration at the Paradise Lake gold project in central Newfoundland. On May 6, 2026, the Issuer announced the results of its initial evaluation of historical data on the Project, highlighting strong prospectivity including surface mineralization up to 144.7 g/t gold, historic drill intersections of up to 10.21 g/t gold over 0.5m, and a 10-kilometre length of prospective terrane. On May 19, 2026, the Issuer announced commencement of field exploration at Paradise Lake, with a field crew deployed to evaluate the approximately 10 km of known gold-anomalous trend. The Issuer also continued its normal corporate and administrative operations during the month.**

**During the month, management oversaw the completion and release of the initial evaluation of historical data on the Paradise Lake gold project, coordinated the commencement of field exploration at Paradise Lake, continued planning exploration and development work programs for the Company's properties, and carried out general corporate and administrative operations.**

**On May 6, 2026, the Issuer announced the results of its initial evaluation of historical data on the Paradise Lake gold project, confirming strong prospectivity including: surface float samples grading up to 144.7 g/t gold; historic drill intersections of up to 10.21 g/t gold over 0.5m with visible gold (DDH PL-22-07); a 10-kilometre length of prospective terrane within the Central Newfoundland gold belt; and alignment of geological, geochemical and geophysical evidence across multiple targets. On May 19, 2026, the Issuer commenced field exploration at Paradise Lake, with initial work consisting of geological mapping, sampling, a drone magnetic survey and a ground induced polarization survey, with the objective of developing drill targets. A trenching program is contemplated for summer.**
