On October 14th 2020 the Company announced the signing of a reseller agreement with Sticky Media, a digital and physical sign manufacturer based in Montreal, Canada with over 1500 clients in the last 15 years including Psycho Bunny, Vans, Dominos and Pajar.

On October 21st, 2020 the Company announced it's first ever mobile WebAR Retail Project launching in December 2020. A new product offering for ImagineAR and first commercial agreement to provide "non-app" augmented reality experiences for a major retail campaign program using 3D models. Consumers will experience augmented reality using their mobile phone cameras without downloading an app in retail environment.

On October 26th, 2020 the Company announced that Andrew Beranbom has joined the Company as an Advisor to the CEO for the purpose of launching Immersive AR Engagement during Live Streaming Branded Music Concerts.

On October 29th, 2020 the Company announced that Alen Paul Silverstieen, CEO of ImagineAR, will be speaking at the Global XR Bootcamp 2020. The Online Global XR Bootcamp 2020 will be the biggest online, Virtual, Augmented and Mixed Reality event in the world and will be hosted November 13th – 14th, 2020. The event will consist of a 24-hour live stream of high-quality sessions by global speakers planned around the world through all the time zones.

On March 11, 2020, the World Health Organization declared the outbreak of the novel strain of coronavirus (“COVID-19”) a pandemic, which has resulted in governments worldwide enacting emergency measures to combat the spread of the virus.

These measures, which include the implementation of travel bans, self-imposed quarantine periods and social distancing, have caused material disruption to businesses globally resulting in an economic slowdown.

Global equity markets have experienced significant volatility and weakness. Governments and central banks have reacted with significant monetary and fiscal interventions designed to stabilize economic conditions. The duration and impact of the COVID-19 outbreak is unknown at this time, as is the efficacy of the government and central bank interventions.
