On December 17, 2019, the Issuer announced that it had entered the Montana cannabis market by successfully integrating its point-of-sale (POS) solution with Montana's METRC seed-to-sale requirements. The Issuer's POS is now available to all Montana medical marijuana dispensaries.

Management continued to support the Issuer's business activities in December 2019, including the activities set out in item 1 above.
