On February 24, 2021 the issuer announced that the PRT XV-S drone has passed more than 20 hours of flight testing.

On February 17, 2021 the issuer had announced that the United Nations (UN) mission in Somalia, using a PRT drone on a routine return delivery, broke the existing beyond visual line of sight (BVLOS) drone delivery record. Plymouth Rock believes that this flight has set an additional new record for complete 'round trip' autonomous delivery capability.

On February 9, 2021 the issuer announced that its CODA-1(Cognitive Object Detection Apparatus) system has undergone further successful testing for detection of various concealed weaponry on a person at our PRT laboratories.

On February 3, 2021 the issuer announced the latest addition to its PRT X1 and XV UAV (Unmanned Aerial Vehicle) payload systems.
