Pasinex Resources Limited is a Toronto-based mining company, which owns 50% of the producing Pinargozu high grade zinc mine. The Company's joint venture sells directly to zinc smelters and or refiners through commodity brokers from its mine site in Türkiye. The Company also holds a 51% interest, with an option to increase to an 80% interest of a high-grade zinc exploration project, the Gunman Project, located in Nevada. Pasinex has a strong technical management team with many years of experience in mineral exploration and mining project development.

Mine production continues at the Pinargozu mine in Turkey. Production is now on a two-shift per day basis. Production is currently estimated at between 500 and 1,000 tonnes combined of oxide and sulphide product each month. Production at the joint venture has averaging between this level for the past few months but is less than what was originally predicted at the beginning of last year. The Company will provide an update on the annual production achieved compared to budget in the coming weeks.
