Through its subsidiaries, Quadron delivers a variety of products and services structured to address the complex needs and requirements of cannabis industry participants in Canada and the US, as well as a variety of other sectors. Quadron's principal focus is on the design and production of automated cannabis extraction and processing equipment (via Soma Labs). In addition, the Company distributes ancillary products, such as customized dispensing devices (i.e. vaporizer pens) along with a variety of packaging options (via Greenmantle). Quadron's subsidiary, Cybernetic, specializes in providing equipment automation services, control solutions and process manufacturing expertise to a variety of industry sectors.
