In a press release dated July 5, 2021, the Company announced that it continues to work closely with its auditor to overcome delays as a result of complexities caused by COVID-19 in Nigeria, Mauritius and Canada in preparing its financial statements for the fiscal year ended December 31, 2020 (the "Annual Financial Statements") and related MD&A and officer certifications (collectively, the "Annual Filings").

The Corporation was informed in the first week of February 2021 of a lawsuit

filed in Nigeria against the Corporation by certain of its Nigerian-resident shareholders, resulting in the suspension of part of the dividend payments due from one of the Corporation's hydro investments, MESL. This dispute is ongoing.

Earlier in 2021, the Corporation successfully exchanged a portion of its Nigerian funds into dollars, although the FX rate was well below levels prevalent in 2020.**
