The Corporation was informed in the first week of February 2021 of a lawsuit filed in Nigeria against the Corporation by certain of its Nigerian-resident shareholders, resulting in the suspension of part of the dividend payments due from one of the Corporation's hydro investments, MESL. This dispute is ongoing.
