The Company issued 3,000,000 common shares in accordance with the terms of an acquisition agreement on the Nixon Bartleman property.

The Company completed a non-brokered private placement financing raising gross proceeds of \$26,000 through the issuance of 520,000 common share units ("Common Units") at \$0.05 per Common Unit. Each Common Unit consisted of one common share in the capital of the Company and one whole common share purchase warrant ("Common Warrant"). Each Common Warrant entitles the holder

to purchase one common share in the capital of the Company at a price of \$0.10 for a period of 24 months following closing.

The Company issued 1,650,000 options to officers and directors exercisable for a period of five years at an exercise price of \$0.07. The options vest 50% upon grant and 50% six months from the date of grant.
