The Company prepared its Management Information Circular and Proxy in respect to its Annual General Meeting (“AGM”) for all shareholders as of record date September 28, 2021. The AGM will take place in Vancouver, BC on November 4th, 2021.

Silver Sands management continues to monitor the activities of its Virginia Silver Project and expects to announce further updates in the coming weeks.

About Silver Sands Resources Corp.

Silver Sands is a well-financed, Canada-based company engaged in the business of mineral exploration and the acquisition of mineral property assets in mining-friendly jurisdictions. Its objective is to locate and develop economic precious and base metal properties of merit. Its key asset is the Virginia silver project, located in the

mining-friendly Santa Cruz state of Argentina.

2. Provide a general overview and discussion of the activities of management.

During September 2021, management's principal activities included additional in-depth review of the results to date from its exploration programs conducted on the Virginia silver project and the planning and implementation of a 3rd phase drill and exploration program with the team at Mirasol Resources Ltd. ("Mirasol").

Last month, Silver Sand's management formally approved the 3rd budget for the period from October 2021 to mid to late November 2021 and to complete the 3rd cash call for the Virginia Project under the Option Agreement dated May 20th, 2020 with Mirasol.

Budget: The budget was prepared to deliver an exploration program that is expected to achieve:

- **_ Recover winter camp supervision and maintenance costs**
- **_ Phase III 2700m drill program**
- **_ Costs for the Phase III drill program design. Geologist, GIS, etc.**
- **_ Two full campaigns of IP PDP electrical geophysical survey program**

The Issuer competes with other companies with greater financial resources and technical facilities. The Issuer may be affected by political, economic, environmental and regulatory risks beyond its control. The Issuer is currently largely dependent on the performance of its directors and officers and there is no assurance the Issuer can retain their services. In recent years both metal prices and publicly traded securities prices have fluctuated widely.
