Effective June 8, 2020, the Company changed its name from "Golden Opportunity Resources Corp." to "Silver Sands Resources Corp.", to reflect the nature of its advanced-stage Virginia silver project in the prolific Santa Cruz province, Argentina, with a new trading symbol of "SAND". The new CUSIP for the Company's shares will be 828122101 and the new ISIN number will be CA8281221017
