**On February 11, 2021, the Issuer entered into an option agreement (the “Option Agreement”) with Vulcan Minerals Inc. (“Vulcan”), of St. John’s, Newfoundland and Labrador, the registered and beneficial owner of certain mineral claims known as the “Gander” property located in Newfoundland and Labrador (the “Property”), pursuant to which Vulcan has agreed to grant the Issuer the exclusive option to acquire 100% interest in the Property.**

**The Property consists of eight claim blocks (624 total claims, 156 km<sup>2</sup>), including Gander North, Gander South, (57 Claims, 14 km<sup>2</sup>), Gander West (20 Claims, 5 km<sup>2</sup>), Lizard Pond (60 Claims, 15 km<sup>2</sup>), Mt. Peyton (30 Claims, 8 km<sup>2</sup>), Little River East (107 Claims, 27 km<sup>2</sup>), Gander Northeast and Hermitage Fault (253 Claims, 63 km<sup>2</sup>).**

**The Issuer entered into the Option Agreement with Vulcan on February 11, 2021, pursuant to which the Issuer was granted the exclusive option to acquire the Property from Vulcan in exchange for the following remuneration:**

- **\$400,000 cash payable over four years (\$100,000 immediately for Year 1)**
- **Exploration expenditures of \$2,000,000 over four years (\$200,000 in Year 1)**
- **2,500,000 common shares (the “Shares”) of the Issuer to be issued as set out in Item 3(c) below.**

**The Issuer is at arms’ length to Vulcan.**

## Appendix A

### PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9
