**The Company will use the proceeds of the private placement for exploration of its Gander properties in Newfoundland.**

**All securities issued are subject to a four-month hold period from closing of the private placement.**

**Sean McGrath, chief executive officer and a director of the company, subscribed for 500,000 shares, Ken Brophy, chief financial officer and a director of the company, subscribed for 300,000 shares, Roger March, a director of the company, subscribed for 200,000 shares, and Lindsay Hamelin, corporate secretary of the company, subscribed for 133,333 shares. As a result, the private placement is a related party transaction (as defined under Multilateral Instrument 61-101, Protection of Minority Security Holders in Special Transactions). The company relied upon section 5.5(a) and 5.7(a) as neither the fair market value of the subject**

**matter of, nor the fair market value of the consideration for, the private placement exceeds 25 per cent of the company's market capitalization (calculated in accordance with MI 61-101).**
