Its products combine CBD with herbal and organic ingredients, all of which are selected for their beneficial properties to soothe,

rejuvenate, and reduce inflammation. In addition to high-end finished products, Sweet Earth prides itself on sustainability by minimizing the use of plastics in both production and packaging.

Sweet Earth's in-house genetics team has been working on its own proprietary hemp strain. This strain has been grown in its indoor greenhouse resulting in high-yielding CBD rich flower. Over the past month, the Issuer has been active in advancing the business plan as described below.

- On October 15, 2020, the Issuer announced that it had it had announce that it has developed a proprietary online shopping portal for discerning pet owners. The portal, [www.sweetearthpets.com](http://www.sweetearthpets.com) focuses on CBD infused pet treats, provides valuable information on CBD usage for pet owners, and features seven of its popular dog treats. The treats are comprised of high-quality ingredients, which are further enriched with CBD. The Company launched seven flavours.
- The Company also announced that it had garnered OTCQB status on October 20, 2020 ad that it had retained of Annapolis, Maryland in the United States to provide ongoing marketing services including content distribution and advertising for the US market.
