Terranueva is now waiting for Health Canada comments.

Terranueva has now completed 12 harvests in its certification unit. Of the crops harvested to date, 2 harvests have been set aside for research and development purposes. All other harvests are kept in inventory pending receiving the required authorizations from Health Canada.


