Terranueva is still in the process of submitting, to Health Canada, its application to amend its license in order to receive authorization for sale of finished products on the retail cannabis market.

Terranueva has now completed 11 harvests in its certification unit. Of the crops harvested to date, 2 harvests have been set a side for research and development purposes. The ninth harvest will take place in May. All other harvests are kept in inventory pending receiving the required authorizations from Health Canada.

Following government statements and public orders related to the COVID-19 pandemic, Terranueva is keeping its activities to a minimum in order to preserve its biological assets. The Company remains on the lookout for economic support programs implemented by the federal and provincial governments and will apply to those available to Terranueva.


