1933 Industries is a Canadian-based, US operated cannabis consumer branded goods company with cultivation, extraction and manufacturing assets based in Las Vegas, Nevada. The Company operates under two subsidiaries: 91%-owned

Alternative Medicine Association (AMA), a licensed cannabis cultivator and producer in the state of Nevada; and 100%-owned Infused MFG (Infused), a manufacturer of wellness products. With a focus on the Nevada market, the Company wholesales its AMA and Level X branded premium flower and AMA line of concentrated cannabis products to legal dispensaries in the state. The Company also formulates and manufactures its own CBD infused line of Canna Hemp™ and Canna Hemp X™ branded goods now sold across the United States.

- There were no significant activities to report this month. The Company continues to cultivate, harvest and sell its cannabis flower, pre-rolls and extraction products to dispensaries in Nevada and markets its CBD-infused products via ecommerce.

3. Describe and provide details of any new products or services developed or offered.

- The Company launched two new products under the Canna Hemp™ line: CBD+CBG Relief Cream and CBD+CBG Recovery Cream. The new topical skus enhance Canna Hemp™'s line of pain release products with the addition of cannabigerol or CBG, a potent and effective cannabinoid. The Company has introduced several new products in 2022 that contain CBG, in order to differentiative its product offerings and strengthen its formulations. Earlier this year, the Company launched CBG Oil Natural Tinctures in 1000mg and 2000mg, Relief Gummies and Immunity gummies in both 15 and 30 counts. Utilizing new cannabinoids in Canna Hemp™ formulas enhances product offerings to suit customer's preferences and needs.
- The Company also launched a Canna Hemp™ Affiliate Program, offering a commission-based referral program to the public.

- No products were discontinued during October.
