On May 3, 2018 the Issuer announced an update on construction at its North Okanagan site of True Leaf Campus in Lumby, British Columbia. A development permit has been submitted and approved and a building permit has been submitted. Construction is scheduled to be completed by fall 2018.

On May 8, 2018 the Issuer announced the addition of its first line of hemp-based treats specially formulated for cats. The cat treats have a crunchy outer shell and a soft inner core made with hemp, a first to the industry world-wide. The functional treats will provide calming support for cats, promote skin and coat health, help prevent hairballs and also support urinary tract function.
