On October 15, 2018, Christopher Spooner resigned his position as Chief Scientific Officer of the Issuer.

On October 16, 2018, Bal Bhullar resigned his position as Corporate Secretary of the Issuer. Mr. Bhullar continues in his role as General Counsel of the Issuer.

On October 17, 2018, the Issuer issued 100,000 shares at a deemed price of \$0.60 per common share to CFO, Kerry Biggs, pursuant to the terms of his employment agreement.

On October 24, 2018, the Issuer announced an update on the status of the True Leaf Campus build in Lumby, BC. The build is on schedule for completion in the fall of 2018.
