**The Issuer continues to explore providing investors with a diversified, high-growth, cannabis investment strategy through strategic investments focused through-out the value chain (cultivation, processing and distribution, and including ancillary business).**

2. Provide a general overview and discussion of the activities of management.

**The Issuer continues to aim to be a go-to capital provider for early-stage global cannabis initiatives with an emphasis on state compliant opportunities in limited licensed jurisdictions in the United States.**

**On July 3, 2020 the Issuer announced the issuance of an Unsecured Convertible Debenture in the principal amount of US\$1,300,000.00 (the "Debenture") to a private investment fund. The Debenture matures on July 3, 2022, with an interest rate of 8.0%, and is convertible at the option of the Holder into 26,000,000 common shares of the Issuer. Proceeds from the Debenture were used to purchase from the Holder a convertible promissory note, issued by Galenas LLC ("Galenas"), with a face value of US\$1.3 million, interest of US\$10,400 payable monthly, and maturing on August 1, 2021 (the "\$1.3 MM Galenas Note"). The \$1.3 MM Galenas Note is convertible, upon the holder's option and subject to regulatory approvals, into 223 membership units of Galenas, which represents approximately a 10.3% equity interest. Upon the purchase of the \$1.3 MM Galenas Note, the Issuer has the right to convert into 45% of Galenas membership units as the Issuer currently holds a \$3.3 million note issued by Galenas which converts, at the Issuer's option, into a non-dilutive 35% equity interest in Galenas.**
