In mid October 2020 the Company announced the mobilization of a diamond drill to its Daniel's Harbour, Newfoundland property to commence its 2020 drill program to further exploration and definition of zinc deposits on the property. Due to delays caused by the late return of the contractors' equipment from a previous work site the mobilization was delayed and it was month end before set up was completed

and drilling initiated. Cold weather also required the installation of water heating equipment.

A small program of soil sampling was undertaken on the East Mineral License at the Daniel's Harbour property to fill in a gap in the coverage of the area previously surveyed and reported on. See Ubuque website for plot of soil results and also additional information including a video of the drilling work.

The Company held its Annual General Meeting on October 28, 2020.
