*In December 2020 the Company continued with its post drill-program analysis and documentation.*

*On December 31, 2020, the Company closed its previously announced non-brokered private placement, raising \$70,000 from the issuance of 1,000,000 hard dollar units at \$0.07 per unit. Each hard dollar unit consists of one common share in the capital of Ubique and one common share purchase warrant, with each whole warrant being exercisable at a price of \$0.15 per common share for a period of 24 months from the date of issuance. All the units were subscribed for by an officer and director of the Corporation.*

*The Company announced on December 1st, 2020, that it had retained Proconsul Capital Ltd to provide investor relations services for the company. The contract provides for monthly service periods and with the company having the right to terminate the contract by giving a 30-day notice at any time. The monthly fee for their services is \$5,000.00 and in addition they have been granted 210,000 options for Ubique common shares with a strike price of \$0.075 per share with one third of the options vesting on the grant date and the balance equally on the next two anniversary dates.*
