The Issuer is a lithium exploration and mining company focused on acquiring and putting lithium projects into production. Additionally, the Issuer actively looks for technologies to streamline the mining process to ensure the efficient transport of raw materials from mine to end user and software to certify environmentally-friendly mining practices and ethically-mined material certifications.

On January 22, 2018, the Issuer announced it has commenced Phase I of its exploration program at its Big Smoky Valley Brine Lithium Property located in Esmeralda County, Nevada, USA (the "Property").

The exploration work includes property wide soil/sediment sampling to understand the distribution pattern of lithium in shallow subsurface sediments across the Property, and to define target areas for further drilling if warranted. The program also includes one more round of water sampling from an existing monitoring well drilled in 2016 (BSV16-02) to see variations in lithium values over time. The Issuer will evaluate its options for further work based on the results of the current exploration work.

During the month of January 2018, in addition to Item 1 above, the Issuer scheduled an Annual General Meeting of Shareholders to be held March 29, 2018.
