The Issuer entered into a property option agreement dated May 26, 2021 (the “Agreement”) with Omenica Syndicate Exploration Limited Partnership, by its general partner, DL Cooke & Associates Ltd. (the “Vendor”), which follows an exclusivity agreement entered into with the vendor on November 19, 2020 (the “Exclusivity Agreement”), to earn a 100% interest (the “Option”) in and to certain mineral claims located in north central British Columbia covering approximately 8,000 hectares generally known and described as the Red Claims or Red Property group (the “Project”), subject to royalties (the “Royalty”). The Vendor is arm’s length to the Issuer. In connection with the Option, the Issuer has agreed to compensate the Vendor, subject to Exchange approval as follows: (A) cash payments totaling \$220,000 as follows: (i) \$5,000 on execution of the Exclusivity Agreement; (ii) \$5,000 on the execution of the amendment to the Exclusivity Agreement; (iii) \$10,000 on signing of the

Agreement; (iv) \$20,000 on or before the 1st anniversary of signing the Agreement; (v) \$30,000 on or before the 2nd anniversary of signing the Agreement; (vi) \$40,000 on or before the 3rd anniversary of signing the Agreement; (vii) \$50,000 on or before the 4th anniversary of signing the Agreement; and (viii) \$60,000 on or before the 5th anniversary of signing the Agreement; (B) issue 1,800,000 common shares, at a deemed price per common shares permitted by the Exchange as follows: (i) 150,000 common shares within 10 days of signing of the Agreement; (ii) 150,000 common shares on or before December 31, 2021; (iii) 250,000 common shares on or before December 31, 2022; (iv) 350,000 common shares on or before December 31, 2023; (v) 400,000 common shares on or before December 2024; and (vi) 500,000 common shares on or before December 31, 2025; and (C) incur exploration expenditures as follows (i) not less than \$50,000 on or before December 31, 2021; (ii) not less than \$125,000 on or before December 31, 2022; (iii) not less than \$200,000 on or before December 31, 2023; (iv) not less than \$300,000 on or before December 31, 2024; and (v) not less than \$400,000 on or before December 31, 2025, ((A), (B) and (C) above collectively the "Option Consideration"). On exercise of the Option after payment of the Option Consideration (the "Option Exercise Date") the Issuer will grant the Vendor a Royalty equal to 2% net smelter returns ("NSR") on certain claims (the "Original Property") and 1.25% NSR on additional claims (the "Additional Property"), the Issuer may reduce the Royalty on the Original Property at any time from 2% NSR to 1% NSR by paying the Vendor \$1,000,000 and may reduce the Royalty on the Additional Property from 1.25% NSR to 0.25% NSR by paying the Vendor \$1,000,000, instalments of the Royalty payable to be paid by the Issuer to the Vendor quarterly, commencing with the quarter in which commercial production commences ("Commercial Production"). Commencing on the one year anniversary of Option Exercise Date, the Corporation will pay \$30,000 to the Vendor as a pre-Commercial Production royalty payment (the "Annual Pre-Payment"), the Issuer will pay the vendor the Annual Pre-Payment once per year on the anniversary of the Option Exercise Date until the earlier of (i) the Commercial Production; and (ii) the date on which the Vendor terminates its Option.

PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9

The Canadian Securities Exchange and its subsidiaries, affiliates, regulators and agents (collectively, “CSE or the “Exchange”) collect and use the information (which may include personal or other information) which has been provided in Form 9 for the following purposes:

- To determine whether an individual is suitable to be associated with a Listed Issuer;
- To determine whether an issuer is suitable for listing;
- To determine whether allowing an issuer to be listed or allowing an individual to be associated with a Listed Issuer could give rise to investor protection concerns or could bring the Exchange into disrepute;
- To conduct enforcement proceedings;
- To ensure compliance with Exchange Requirements and applicable securities legislation; and
- To fulfil the Exchange’s obligation to regulate its marketplace.
