Xcite is an early-stage exploration company working to become a leader in the discovery and development of energy transition metals. The uranium project portfolio in the Athabasca basin will propel the Company's efforts to achieve a high-grade discovery based on new geological modelling and

exploration thesis in a past-producing uranium camp dormant for 40 years. The Uranium City project portfolio constitutes the Don Lake, Beaver River, Smitty, Lorado, Gulch and Black Bay properties.

On April 7, 2026, the Company announced that, pursuant to a debt settlement agreement dated as of April 7, 2026, it will issue an aggregate of 262,500 common shares at a price of \$0.16 per share to an arm's length creditor to settle \$42,000 of debt for services previously provided by the creditor to the Company. When issued, the Shares will be subject to a four month hold period in accordance with applicable securities laws and the policies of the Canadian Securities Exchange.
