## Annual & Interim Financial statements Postponed & Virtual Shareholders Meeting

**On April 28, 2020,** the Company informed its shareholders that it elected to use the provisions of BC Instrument 51-515 in order to postpone the fillings of its 2019 annual audited financial statements and interim financial statements for the first quarter of 2020. At this time, the Corporation expects to file the Documents within the 45 days delay granted.
