TANTALEX RESOURCES CORPORATION ANNOUNCES RELIANCE ON TEMPORARY RELIEF FOR THE FILING OF ITS INTERIM (Q1) FINANCIAL STATEMENTS

Toronto, Ontario, August 4th, 2020 – TANTALEX Resources Corporation (CSE:TTX – FSE:1T0) (“**Tantalex**” or the “**Corporation**”), announces that on May 20th, 2020, the Ontario Securities Commission published a *General Order for Temporary Exemption from Certain Corporate Finance Requirements with Deadlines during the Period from June 2 to August 31, 2020* as a result of COVID-19. The Company intends to rely on the temporary relief, which provides for a forty-five (45) days extension to file its interim annual financial statements and related MDA for the period ending July 31, 2020.

The preparation of its financial statements is ongoing and the Company expect to file its interim financial statements and accompanying MD&A on or before September 14th, 2020.

The Company also hereby confirms that there have been no material business developments since its last interim financial reports (Q3) as at November 30, 2019 that were filed on January 20, 2020 which have not already been disclosed to the public. As previously announced on June 25, 2020, the audit of its financial statements is nearing completion and the Company expect to file its audited annual financial statements and accompanying MD&A on or before August 12, 2020.

Furthermore, the Company’s directors, officers and other insiders will be subject to a trading blackout until such time as the audited annual financial statement are filed.
