The Lenders will receive a combined total of 6,450,000 common shares of the Company at a deemed price of \$0.10 per share as payment of the Loans (the "Loan Settlement"). Of the total debt, \$304,000 representing an aggregate of 3,040,00 shares has been issued to two insiders at the deemed price of \$0.10 per share. Shares issued will subject to a four-month hold period from the date of issuance in accordance with applicable securities law, and will be subject to exchange approval.
 - EasyMed Smartcare technology was successfully deployed at the University Hospital of Geneva cardiac department. Currently the company is holding new discussions to implement the smartcare soft in other hospitals within the department. No deal has yet been reached.
 - Late-stage talks with Netdoctor, a UK-based online health portal, to help them to deploy mobile services
 - Discussions with Healthcare International, a UK-based health insurance broker, to offer the International Medical Passport to its corporate and retail consumers
