The product is readily available for sale through a prescription in all major pharmacies across the U.S. **OMAZEN**<sup>®</sup> is a pharmaceutical grade Omega-3 providing over 90% pure Omega-3 in each capsule for the maintenance of good health. **OMAZEN**<sup>®</sup> is available for sale and distribution in Canada.

Management is continuing to work and deliver on the objectives laid out in the business plan to grow sales of its lead products **VASCAZEN**<sup>®</sup> and **OMAZEN**<sup>®</sup> to increase shareholder value. To support this effort management announced it has retained Kilmer Lucas Inc. to provide the Company with Canadian and U.S. investor relations and strategic advisory services. On June 17, 2014 the Company held its Annual General Meeting (AGM) and re-elected five directors and re-appointed MNP LLP as the auditors of the Company.
