The issuer, "Cannabix Technologies Inc.", or "Cannabix", or "the Company" is the developer of the patent pending Cannabix Marijuana Breathalyzer for law enforcement. Cannabix is advancing its products to enable law enforcement personnel to use this

technology to enhance detection of marijuana impaired driving offences on North American roads at a time when marijuana is becoming legal in many jurisdictions.

During the month of August the Issuer's management team continued to develop the Cannabix marijuana breathalyzer, changed its corporate name from West Point Resources Inc to Cannabix Technologies Inc. and became quoted on the US OTC Pinksheets under the symbol BLOZF.

The Company continued prototype development of its Cannabix marijuana breathalyzer.

In Canada, marijuana use for medical purposes is legal under the country's Marihuana Medical Access Regulations and Marihuana for Medical Purposes Regulations.
