Mr. Munro, Mrs. Munro, Intrinsic Venture Corp. and Embella Holdings Ltd. are hereinafter together referred to as the "Offeror".

**2. Designation and number or principal amount of securities and the Offeror's security holding percentage in the class of securities of which the Offeror acquired ownership or control in the transaction or occurrence giving rise to the obligation to file the news release, and whether it was ownership or control that was acquired in those circumstances:**

The Offeror purchased, pursuant to a debt settlement, and subsequent private placement subscription agreement dated September 2<sup>nd</sup>, 2014 (the "**Subscription Agreement**"), directly from Auxellence Health Corporation (the "**Company**") an aggregate of 6,530,000 units (the "**Units**") of the Company by way of a non-brokered private placement (the "**Private Placement**") at a price of Cdn\$0.05 per Unit, for gross proceeds to the Company of Cdn\$326,500. Each Unit comprises of one (1) common share (each, a "**Unit Share**") and one (1) common share purchase warrant (each, a "**Warrant**") of the Company. Each Warrant will entitle the holder thereof to purchase one (1) common share (each, a "**Warrant Share**") of the Company at a price of Cdn.\$0.10 per Warrant Share at any time on or prior to the date that is five years following September 2<sup>nd</sup>, 2014 (the "**Closing Date**"), the date of closing the Private Placement.

As a result, as of the date of this report, the Offeror is deemed the beneficial owner of the 6,530,000 Warrant Shares issuable on exercise of the Warrants acquired under the Private Placement (the "**Deemed Ownership Shares**"), even though the Deemed Ownership Shares are currently unissued, under applicable securities laws.

The 6,530,000 common shares and the 6,530,000 Deemed Ownership Shares acquired by the Offeror under the Private Placement represent approximately 10.17% of the fully diluted 128,380,884 issued and outstanding common shares of the Company following the closing of the Private Placement (and assuming conversion of all of the Deemed Ownership Shares).

A news release in connection with the foregoing was issued by the Offeror on September 19<sup>th</sup>, 2014 and filed with Canadian securities regulatory authorities on the System for Electronic Document Analysis and Retrieval ("**SEDAR**") at [www.sedar.com](http://www.sedar.com).

**3. Designation and number or principal amount of securities and the Offeror's security holding percentage in the class of securities immediately after the transaction or occurrence giving rise to the obligation to file the news release:**

The Offeror also has an option to acquire 30,000 common shares from a third party shareholder.

Following the closing of the Private Placement, the Offeror beneficially owns (including the 30,000 options referenced above) 9,970,500 common shares of the Company (excluding the Deemed Ownership Shares), representing approximately 9.46% of the Company's current issued and outstanding common shares, representing 105,379,284 common shares.

If the Deemed Ownership Shares and the 30,000 optioned common shares are included, following the closing of the Private Placement, the Offeror would beneficially own 16,500,500 common shares of the Company, representing approximately 12.85% of the Company's then fully diluted issued and outstanding common shares, representing 128,380,884 common shares.

The Offeror acquired the 6,530,000 Units pursuant to the Private Placement for investment purposes. Depending on economic or market conditions or matters relating to the Company, the Offeror may choose to either acquire additional common shares or dispose of common shares of the Company.

General nature and the material terms of any agreement, other than lending arrangements, with respect to securities of the reporting issuer entered into by the Offeror, or any joint actor, and the issuer of the securities or any other entity in connection with the transaction or occurrence giving rise to the news release, including agreements with respect to the acquisition, holding, disposition or voting of any of the securities:**

The 6,530,000 Units acquired pursuant to the Private Placement were acquired in reliance upon the shares for debt exemption under section 2.14 of National Instrument 45-106 – *Prospectus and Registration Exemptions*.
