## PIVOTAL THERAPEUTICS ANNOUNCES PAYMENT OF INTEREST ON OUTSTANDING CONVERTIBLE NOTES

**Woodbridge, Ontario, January 5, 2015 - Pivotal Therapeutics Inc. The issued and outstanding number of shares now total 93,469,236.
