The Issuer primarily invests in senior debt, preferred shares and debt obligations which are convertible into equities, of eligible businesses which have the greatest potential for long-term growth and may also invest in equity and other equity-related securities. The Issuer is focused on funding rapidly growing Canadian companies by providing them with the capital needed to execute their growth strategies and acquisition plans. The Issuer also focuses on companies with recurring revenue streams in the technology, healthcare and financial services industry. The Issuer will initially focus its investments on companies in the expansion phase of development in mid to late stages. In addition, the Issuer may acquire previously issued securities of companies from holders of such securities.

The General Partner, through its general partner, T1 General Partner Corp., is responsible for the management of the Issuer. The General Partner and the Issuer have enter into an advisory services agreement with B.E.S.T. Investment Counsel Limited under which B.E.S.T. Investment Counsel Limited has agreed to provide certain investment advisory services.
