Over the previous month, the Issuer's business activities have been focused on continuing the commercialization of its lead products **VASCAZEN**<sup>®</sup>, **OMAZEN**<sup>®</sup> and a new product **BeneFishial**<sup>™</sup>. **VASCAZEN**<sup>®</sup> is a prescription-only medical food for the dietary management of an Omega-3 deficiency in patients with cardiovascular disease. The product is readily available for sale through a prescription in all major pharmacies across the U.S. **OMAZEN**<sup>®</sup> is Pivotal's second product to market for the maintenance of good health, contains greater than 90% pure pharmaceutical grade Omega-3 with the optimal 6:1 ratio of EPA to DHA. **OMAZEN**<sup>®</sup> is available for sale and distribution in Canada only and is positioned for the professional OTC market. **BeneFishial**<sup>™</sup> is the first product in Pivotal's new nutraceutical product line, which has been specifically designed to be sold in the OTC direct to retail and/or direct to consumer markets.

During the month, the Company issued 763,752 common shares of the Corporation (the "Common Shares"). The Common Shares represented payment of interest for the period of December 5<sup>th</sup>, 2014 to March 4<sup>th</sup>, 2015 on its outstanding Convertible Notes that is due on or before April 1, 2015. Interest on the Notes, at the rate of 8% per annum, is payable quarterly in either cash or Common Shares, at the option of the Company. Common Shares issued in payment of interest are valued at the greater of CDN \$0.20 per share and such price as may be allowed under the CSE Policy. The issued and outstanding number of shares now total 94,232,988.
