Brisio Innovations Inc. ("Brisio" or the "Company") is focused on the acquisition, development and marketing of software applications for mobile computing devices, including smartphones, tablets, and wearable computers.

Throughout the month of July, the Company continued reviewing the strategic direction of the OakBranch Media Inc. ("OakBranch") investment. The Company also remained in contact with management of investees Lite Access Technologies Inc. ("Lite Access") and Intema Solutions Inc. ("Intema").

Brisio held its Annual General Meeting on July 28, 2015. There were no changes in directors, officers or committee members.

Management was actively engaged in all general administrative and sundry duties of the Issuer, and focused on the strategic direction of the OakBranch Media Inc. investment and creating strategic relationships. The Company also remained in contact with management of investees Lite Access Technologies Inc. ("Lite Access") and Intema Solutions Inc. ("Intema").

Management will continue to closely follow emerging mobile technology trends and develop strategies to benefit from them.
