Over the previous month, the Issuer's business activities have been focused on continuing the commercialization of its lead products **VASCAZEN**[®], **OMAZEN**[®] and a new product **BeneFishial**[™]. **VASCAZEN**[®] is a prescription-only medical food for the dietary management of an Omega-3 deficiency in patients with cardiovascular disease. The product is readily available for sale through a prescription in all major pharmacies across the U.S. **OMAZEN**[®] is Pivotal's second product to market for the maintenance of good health, contains greater than 90% pure pharmaceutical grade Omega-3 with the optimal 6:1 ratio of EPA to DHA. **OMAZEN**[®] is available for sale and distribution in Canada only and is positioned for the professional over the counter (OTC) market. **BeneFishial**[™] is the first product in Pivotal's new nutraceutical product line, which has been specifically designed to be sold in the OTC direct to retail and/or direct to consumer markets. The Company's product line is being expanded to include its first drug candidate **PVT-100** and a point of care diagnostic **OmegaSTAT**[™]. **PVT-100** utilizes **VASCAZEN**[®]'s unique formulation for the stabilization of vulnerable plaque in patients undergoing carotid endarterectomy. **OmegaSTAT**[™] is a rapid format point-of-care (POC) diagnostic test being developed to measure Omega-3 deficiency.

Also, during the month the Company announced the United States Patent and Trademark Office ("USPTO") published notification of a Notice of Allowance for Pivotal's U.S. Patent Application Serial Number 14/594,095 entitled "Process and Composition For Stabilization of Vulnerable Plaque Utilizing a Combination of a Statin and Omega 3 Fatty Acids." This notice constitutes allowance of the patent and impending issuance.
