The Issuer did not amend or abandon any exploration or production programs in the month of October 2015, however, the Issuer has not currently met the initial \$3,000,000 expenditure commitment to Globex Mining Enterprises Inc. (“Globex”) and has made a partial payment of \$25,000 towards the December 31, 2014 instalment of \$100,000 due. The Issuer is currently negotiating updated terms for its option agreement with Globex. There are no assurances that the Issuer will be able to negotiate new terms for the property with Globex that are satisfactory for the Issuer; if the Issuer is unable to do so it will lose its rights to acquire this property.
