The Issuer has one principal property, the "Deer Horn" property, in which it holds a 50% interest. The Company intends to maintain its current resource portfolio. The Company did not undertake any exploration activity on the Deer Horn property in October 2015.

On October 29, 2015, the Issuer announced that it intends to raise up to \$200,000 by way of a non-brokered private placement (the "Offering") of units of the Company @ \$0.10/unit. Each unit will consist of one common share in the capital of Deer Horn and one-half of one (1/2) share purchase warrant. Each whole warrant will be exercisable into one common share for a period of two years at a price of \$0.15.

The Issuer has one retail store location in the natural and organic sector, Bodhi Natural Market. During October 2015, the Company continued to assess potential sites for a second retail location. The Company will continue to focus on growing this business segment.
