 - **On October 21, 2015 the Company announced it has extended the closing of its non-brokered private placement to December 5th, 2015. The non-brokered private placement has been arranged for up to 10 million units ("Units") at a price of \$0.05 per Unit for aggregate gross proceeds of \$500,000 (the "Offering"). Each Unit will be**

comprised of one common share ("Share") and one Share purchase warrant of the Company (a "Warrant"). Each Warrant entitles the holder to purchase an additional Share at a price of \$0.10 per Share for a period of 12 months. Proceeds from the Offering will be used for the Company's short term payables and for general working capital. Finder's fees may be payable in relation to the private placement.

- On October 22, 2015 announced the appointment of Lochlyn Munro by the board of directors as a celebrity advisor to the board and management. Lochlyn Munro is a Canadian actor and Hollywood veteran who brings significant credibility, connections and industry experience to GeoNovus Media.
 - On October 30, 2015, Nick Brusatore filed an early warning report and announced that he has acquired ownership and control of 1,226,400 shares of the Company in the open market. Mr. Brusatore now holds 10% of the issued and outstanding shares of the Company.
