On January 27, 2016, the Company has consolidated its issued and outstanding share capital on the basis of one postconsolidation share for each five preconsolidation common shares. No fractional shares has been issued under the consolidation, and any fraction has been rounded to the nearest whole number.

The consolidation was approved by the shareholders of the company at its annual general and special meeting of shareholders, which was held on December 29, 2015.

As of January 31, 2016, share consolidation transaction is completed. As a result, the outstanding shares of the company is reduced to approximately 13,630,408.

The shares were available for trading on a consolidated basis and with a new Cusip number on January 25, 2016.
