The Issuer continues to focus attention on its wholly-owned subsidiary Armada Group USA, Inc. and Redrock Trading Partners, a fully licensed FINRA broker dealer and financial services affiliated company.

Management, through ArmadaUSA, focused its efforts on generating new broker dealer clients for Redrock Trading Partners while business in the venture lending department continued to slow as a result of focus on fee and commission business increased. Management is seeking to move into the wealth management business through acquisition or joint venturing with asset managers and businesses. Management entered into a confidential letter of intent to acquire a percentage of a USA banking and insurance company. Funding sources and client companies increased for Redrock Trading Partners during the period.

ArmadaUSA completed offering information related to an opportunity fund that will raise capital from investors to invest in profitable revenue client companies and provide bridge loans for companies to the public markets. Redrock is a fully-licensed FINRA registered broker dealer that specializes in arranging capital and financing to high-quality companies, both private and public. In addition, Redrock can provide solutions to companies seeking products and services such as:
