Each unit shall consist of one common share and one-half of one share purchase warrant, where each whole warrant is exercisable for one year at \$0.10 per share. The Company intends to use the proceeds from the private placement to pay outstanding accounts and for general working capital purposes.**

**The Issuer's new Board of Directors and Management met to consider numerous matters including the 'Inlet Property' and 'Carmi' Claims. A decision was reached to employ the use of Mobile Metal Ions (MMI) soil sampling, to better identify potential drilling targets.
