The Issuer's business have been focused on two main areas: 1) initiatives associated with legal action against the Issuer's joint venture partner in China: 2) working towards satisfying the requirements for the lifting of our cease trade order related to late filing of year-end audited financials. The company received a Cease Trade Order effective May 1.

Management activities have been focused on three main areas: 1) the preparation of audited annual financial statements for the year ended December 31, 2008 2) initiatives associated with legal action against the Issuer's joint venture partner in China and 3) preparing a work plan on our Tower Mountain gold deposit option.

HMZ continues to assess new project opportunities but currently has the one option agreement (the "Agreement") with ValGold Resources Ltd. ("ValGold") on its Tower Mountain gold property, located in Conmee Township, Ontario (the "Property").
