The Issuer's "Hoteles Las Americas" hotels in Peru produced record revenues of \$1,578,000 in April 2008. The Issuer's Eastbay Resort and Poro Point Casinos, where the Issuer controls 60% and 61% of the operations

respectively, generated another record revenue of \$3,859,000 for the month of April 2008; the Panama operations, of which the Issuer owns 61.36%, posted revenues of \$5,447,000; and in Costa Rica, of which the Issuer owns 50%, the operation generated record revenues of \$3,002,000; during the month of April 2008 in Guatemala the operations generated revenue of \$327,000; in Nicaragua the three operating casinos of which the Issuer owns 54.6% generated \$1,178,000 in revenue.

Management's primary activity in the month of April was to finalize yearend 2007 audited financial statements, prepare the company's annual report and continue development efforts in Colombia, Guatemala, the Philippines, Poland, and India. Operations in each country continue to meet and in certain cases, exceed management expectations.
