The Company is continuing to raise financing as required in a private placement. The funds will be used to finance the second 60-MW unit at the Company's 60%-owned Yongxing power plant in the Hunan province of China and to begin the feasibility study on the third and fourth units at the power plant.

The Company is pleased to announce that it has retained Paradox IR of Montreal to provide investor relations services to the company. ONA will pay Paradox a monthly fee of \$8,000 and issue 150,000 incentive stock options to Paradox. The options will be granted pursuant to the company's stock option plan. The options will have an exercise price of \$0.80 cents per share for a period of one year, and will vest in equal amounts, on a semi-annual basis, over 18 months. Paradox will provide the services for an initial term of 12 months.
