(CNSX: PDH) is very pleased to inform the public that our Joint Venture partner, the No. 3 Military Police Hospital in Beijing, has had its ranking status upgraded from a Level 2A Hospital to a Level 3A Hospital, the highest ranking for hospitals in China.
