The company continues to look at the redevelopment of the 57 Linelle Street property for residential purposes. This will require amendments to the City of Toronto Official Plan and Zoning By-Laws. The land is currently zoned to permit the construction of a 15,000 crypt mausoleum of approximately 180,000 square feet.

Park Lawn Company Limited and Park Lawn Income Trust had previously announced their intention to combine their respective businesses contemporaneously with the conversion of Park Lawn Income Trust to a corporation. On October 15, 2010, the company announced that after further consideration and analysis it has been determined that there is insufficient merit to proceed with a business combination at this time.

2. Provide a general overview and discussion of the activities of management.

In order to develop the property for any other purpose, an Official Plan amendment and rezoning would be required. The property currently has access from the private drive adjacent to Forest Lawn Mausoleum and is blocked from access to Linelle Street by a one-foot reserve in favour of the City of Toronto. This reserve was granted by the previous owners of Westside Cemeteries Limited as part of the overall rezoning process that permits the mausoleum development on the subject parcel. The City has total control over the possible lifting of the reserve and to date officials have indicated an unwillingness to permit access to Linelle Street from the subject site.
